However, if due to subsequent modifications in the SEBI (LODR) Regulations or any other applicable law, a provision of this Policy or any part thereof becomes inconsistent with the SEBI (LODR) Regulations, the provisions of the SEBI (LODR) Regulations as modified shall prevail.

### **B. Effective Date**

4. This Policy is effective from June 05, 2023.

## C. Familiarization programmes

- 5. The Company shall familiarize the Independent Directors through various programmes about the Company including:
- nature of the industry in which the Company operates;
- business model of the Company;
- roles, rights, responsibilities of Independent Directors; and
- any other relevant information.

The details of familiarization programmes conducted and attended by Independent Directors are included in Annexure – A hereto. The Chief Financial Officer, Chief Compliance Officer and Head – Legal and Company Secretary and Compliance Officer are severally authorized to update the said Annexure as deemed appropriate.
